I acknowledge that participation in a summer camp, respite, after-school, and/or day program/s has inherent risks, hazards, and dangers for anyone, that cannot be eliminated, particularly in a facility serving individuals with disabilities. I understand that these risks, hazards, and dangers include without limitation:

1. Water hazards associated with an on-premise swimming pool, including drowning;
2. Medication errors;
3. Injuries sustained during physical activities;
4. Injuries sustained while in transit to off-premise activities;
5. Injuries sustained while participating in off-premise activities;
6. Injuries sustained due to the physical aggression of other participants and/or intruders;
7. Facility related catastrophes;
8. Temperature extremes;
9. Inclement weather conditions.

I understand the risks, hazards, and dangers of participation in:

1. Summer Camp Programs;
2. Respite Programs;
3. After-School Programs;
4. Day Programs;
5. Other programs that may be offered by Camp Evergreen.

The above named individual is voluntarily participating in the activities at **Camp Evergreen** with full knowledge of the inherent risks, hazards, and dangers involved and hereby assume and accept all risks of injury, paralysis, or death.

In consideration for the above named individual being permitted to participate in the activities offered by **Camp Evergreen**, the undersigned parent, guardian, or custodian of the participant, for himself/herself and on behalf of said participant, agrees to save and hold harmless, indemnify, and forever defend, **Camp Evergreen**, their directors, officers, agents, employees, and volunteers from and against any claims, actions, demands, expenses, liabilities (including reasonable attorneys' fees), and negligence of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly as a result of said participant's use of the services, facility, and equipment at **Camp Evergreen**. I, for myself and on behalf of said participant, further agree not to sue **Camp Evergreen**, because of any injury, paralysis or death that said participant suffers from his/her participation in the activities of **Camp Evergreen**.
